Can local productivity step up to the plate and supply all these quantity. If local productivity cannot supply all, should there be a division of labour whereby some calibrated importation regime is allowable? These are the issues to be decided at the Abuja Solid Mineral Workshop and Exhibition.

NISOMWEX 2012 will gather together in one venue the political actors, the mining and drilling sector stakeholders and the regulatory and research agencies, public and private, to meet with IOCs, oil field companies, equipment makers, equipment vendors, service providers from local and overseas locations and interested investors, miners and entrepreneurs to interact at the 2-day event.
